Recruitment to the posts of Asst. Executive Engineer (Civil) and Asst. Executive Engineer (Mechanical) in Group- 'A' of Odisha Engineering Service under the Water Resources Department

Online applications are invited from the prospective candidates through the proforma application form to be made available on the Website of the Commission (http://opsc.gov.in). The link for online application and submission shall be available from 29.03.2023 to 28.04.2023 (Note: 28.04.2023 is the last date for submission of Registered Online Application) for recruitment to 362(120-W) posts of Assistant Executive Engineer (Civil) under (1) Water Resources Department (2) Works Department (3) H & UD Department of Government of Odisha and for recruitment to 29(09-W) posts of Assistant Executive Engineer (Mechanical) under Water Resources Department in Group-A of Odisha Engineering Service carrying the scale of pay in Level-12 of pay matrix under ORSP Rules-2017 with usual dearness allowance and other allowances as may be sanctioned by the Government of Odisha from time to time.

2. <u>Vacancy Position</u>: As per requisition filed by the Water Resources Department of Government of Odisha the vacancy position are given below:

Out of the vacancies mentioned above 04 (01-W) posts are reserved for Sports persons and they shall be adjusted in the vacancies from the category to which they belong.

As per G.A. Department Resolution No. 24808/Gen dated 18.11.1985, Resolution No. 33044 dated 11.12.2014, Letter No.11819 dated 30.04.2013 and related instructions in force, the Government have extended the benefit of reservation for Sports persons in case of direct recruitment to Group A (JB) services/posts.

The candidates are required to give their preference/choice of Departments in their online application form for the post of Assistant Executive Engineer (Civil).

- N.B.- (1) Out of 4% (four percent) reservation for Persons with Disabilities, 1% (one percent) reservation shall be for women with disabilities.
 - (2) One-third (0.33%) of the posts reserved for Sports Persons shall be for women Sports Persons. The sports persons candidates are required to submit identity card issued by the Director of Sports, Odisha only.

NOTE:

- (a) The probation period of the above post is two years.
- (b) In the event of non-availability or availability of insufficient number of eligible women candidate(s) belonging to any particular category, the remaining vacancies will be filled up by male candidate(s) of that category.
- (c) Exchange of reservation between Scheduled Caste and Scheduled Tribe will not be considered in the event of non-availability of eligible and suitable S.C./S.T. candidates.

- (d) The number of vacancy to be filled up on the basis of this recruitment is subject to change by Government without notice, depending upon the exigencies of public service at the discretion of the State Government.
- (e) Candidates belonging to the category of Persons With Disabilities shall be adjusted against the categories to which they belong.
- 3. **AGE**: A candidate must have attained the age of 21 (twenty one) years as on 01.01.2023 and must not be above the age of 38 (thirty eight) years as on 01.01.2021 i:e he or she must be born not earlier than 02.01.1983 and not later than 01.01.2002. Age relaxation for candidates in different categories for availing relaxation and reservation benefits will be as per Government Rules prescribed for the purpose. The upper age limit is relax-able by 5(five) years for candidates belonging to the categories of Scheduled Castes(S.C.), Scheduled Tribes(S.T.), Socially & Educationally Backward Class(S.E.B.C.), Women, Ex-servicemen, and by 10(ten) years for Persons With Disabilities category, whose permanent disability is 40% and more. As per G.A Department notification No. 17376/GAD-SC-Rules-008/2016/Gen, dated 10.8.2016 the Persons with Disabilities shall be entitled to cumulative age relaxation of 10 years over and above the normal age relaxation.

Provided that the maximum age limit shall be relaxed to 45 years in respect of the candidates who have entered the Diploma Engineers' Service as Junior Engineers whether promoted to the post of Asst. Engineer or not within the prescribed age limit without the qualification prescribed under clause (b) of rule 6 and have subsequently acquired the same while serving as such or have acquired such qualification prior to entering the State Government Service as Junior Engineers subject to availing of not more than 5 chances.

Provided that a candidate who comes under more than one category mentioned above he/she will be eligible for only one age relaxation benefit.

SAVE AS PROVIDED ABOVE THE AGE LIMITS PRESCRIBED CAN IN NO CASE BE RELAXED. Date of birth entered in the high school certificate or equivalent certificate issued by the

concerned board/council will only be accepted by the Commission.

4. <u>EDUCATIONAL QUALIFICATION</u>: A candidate must have possessed a <u>Degree in Engineering in Civil</u> for the post of **AEE** (Civil) and <u>Degree in Engineering in Mechanical</u> for the post of **AEE** (Mechanical) or an equivalent qualification from any University or Institution recognized by the Government or he/she must be an Associated Member of the Institution of Engineers of India in Civil/Mechanical.

5. METHOD OF SELECTION:

- a) The Commission after receipt of the applications shall take steps to select the candidates on the basis of the highest of the valid GATE score of preceding 03 years of the date of advertisement (including the year of advertisement).
- **b)** The Commission, after verification of original certificates & documents, valid GATE scores, shall select the name of suitable candidates in order of merit, as per availability of vacancies in different categories and recommend for appointment to the post of AEEs to the Government.

Any details relating to this recruitment like cut-off scores, individual scores, etc. shall only be declared on the website of the Commission after publication of the final result and select list.

6. APPLICATION FEE:

The candidates are exempted for payment of examination fees as per G.A Deptt. letter No.9897/Gen dated 11.04.2022.

7. OTHER ELIGIBILITY CONDITIONS:

- (i) The candidate must be a citizen of India;
- (ii) He/She must be of good character and of sound health and free from any organic defect and physical infirmity.
- (iii) He/She must be able to read, write and speak Odia and have -
 - (a) Passed Middle School Examination with Odia as a language Subject; or
 - (b) Passed Matriculation or equivalent Examination with Odia as medium of examination in non-language subject; or
 - (c) Passed in Odia as language subject in the final examination of Class-VII from a School or Educational Institution recognized by the Government of Odisha or the Central Government; or
 - (d) Passed a test in Odia in Middle English School Standard conducted by the School and Mass Education Department/Board of Secondary Education, Odisha
- (iv) A candidate, who has more than one spouse living, will not be eligible for appointment unless the State Government has exempted his/her case from operation of this limitation for any good and sufficient reasons;
- (v) Government servants, whether permanent or temporary or on probation against a vacancy in permanent/temporary posts in any department of Government, are eligible, provided they possess the requisite qualification and are within the prescribed age limit as mentioned under Para-3 and Para-4 of this advertisement. They must inform their respective Heads of the Office in writing regarding submission of their application for this recruitment and furnish "No Objection Certificate" during document verification;
- (vi) If a candidate has at any time, been debarred for a certain period/chance(s) by the Odisha Public Service Commission or by other State Public Service Commission or by U.P.S.C. from appearing at any examination / viva voce test, he/she will not be eligible for such recruitment for that specified period / chance(s);
- (vii) Only those candidates, who possess the requisite qualifications, are within the prescribed age limit and fulfill other eligibility conditions etc. by the closing date for submission of online application form, will be considered eligible;
- (viii) A candidate who claims change in his/her name after having passed the H.S.C. examination, is required to furnish copy of publication of the changed name in the local leading daily newspaper as well as copy of notification in the Gazette in support of his/her change of name;
- (ix) Every candidate selected for appointment shall be examined by the Medical Board. A candidate, who does not satisfy the requirement after medical examination, shall not be appointed;

8. IMPORTANT POINTS:

- (i) Online applications submitted to OPSC, if found to be incomplete in any respect, are liable for rejection without entertaining any correspondence with the applicants on the score;
- (ii) A candidate found guilty of seeking support for his/her candidature by offering illegal gratification or applying pressure on any person connected with the conduct of the recruitment process or found indulging in any type of malpractice in course of the selection or otherwise, shall, in addition to rendering himself/herself liable to criminal prosecution, be disqualified not only for the recruitment for which he/she is a candidate, but also may be debarred, either permanently or for a specified period, from any recruitment or selection to be conducted by the Commission;
- (iii) Admission to recruitment process will be provisional. If on verification at any stage of the recruitment process it is found that a candidate does not fulfil all the eligibility conditions, his/her candidature will be liable to rejection. Decision of the Commission in regard to eligibility or otherwise of candidate shall be final;
- (iv) This advertisement should not be construed as binding on the Government to make appointment;
- (v) Concession meant for S.E.B.C, S.C & S.T by birth are admissible to the Socially and Educationally Backward Classes, Scheduled Castes & Scheduled Tribe of Odisha only;
- (vi) Any misrepresentation or suppression of information by the candidate in the application form will result in cancellation of his/her candidature or penalty, as decided by the Commission shall be imposed;
- (vii) Mere empanelment in the select list shall not confer any right for appointment unless the Government is satisfied after making such enquiry as may be deemed necessary that the candidate is suitable in all respects for appointment to the service;

9. CERTIFICATES/DOCUMENTS TO BE ATTACHED:

Only those candidates, who are called for document verification are to submit the printout/hard copy of online applications, along with true copies of the following documents duly self attested by the candidates with full signature and date on the same on the day of document verification. They must also produce original certificates, mark-sheets etc. for verification on the date fixed by the Commission.

If a candidate fails to produce any of the original documents in respect of the attested copies submitted with the application form **on the date of document verification fixed by the Commission**, his/her candidature will be rejected.

- (i) H.S.C. or equivalent certificate in support of declaration of age issued by the concerned Board/Council.
- (ii) Intermediate/+2 Sc. Pass Certificate issued by the concerned University/Council;
- (iii) Degree/Diploma in Engineering (Civil or Mechanical) pass certificate issued by the recognized University or Institution recognized by the Government;

 (iv) Mark-lists of all semesters/annual examinations in support of Degree/Diploma in Engineering (Civil or Mechanical) passed including fail marks, if any, issued by the concerned Board/Council/University;

NOTE 1:

- **(a)** Candidates who have not been awarded percentage of marks, but only **"grade marks"**, should, along with their applications, produce the Conversion Certificate from the concerned University indicating the actual equivalent percentage of marks and the conversion formula, failing which, their applications are liable to be rejected.
- (b) While filling up the relevant box of the online application form, the candidate has to mention the marks secured (excepting marks secured in the Extra Optional/4th Optional Subject) in each examination passed (i.e. H.S.C. to Degree/Diploma).
- (v) Certificate showing valid GATE score.
- (vi) "No Objection Certificate" from the Head of Office/Head of the Department in case of Government servant.
- (vii) Four recent passport size photographs (unsigned and unattested) with the printout/hard copy of online application form which has been uploaded.
- (viii) Certificates of character and conduct from the Principal/Proctor/Dean or Professor in charge of teaching department of the College or University in which he/she last studied;
- (ix) Caste Certificate by birth in support of claim as SC/ST/SEBC, wherever applicable;

NOTE 2:

Candidates claiming to be belonging to S.C. /S.T./ S.E.B.C category by birth are required to submit copy of the relevant Caste Certificate issued by the competent authority in the prescribed form. Candidates of SEBC category (other than Creamy Layer) must submit copy of Caste Certificate issued by the competent authority within the last three years from the last/closing date of submission of online application.

- a. Women candidates belonging to S.C. /S.T. /S.E.B.C Categories are required to submit Caste Certificates by birth showing "daughter of". Caste Certificates by virtue of marriage (i.e. showing "wife of") is not acceptable.
- O.B.C. Certificate Will Not Be Accepted in lieu of SEBC Certificate and Candidates submitting the OBC Certificate are liable for rejection.
- C. Community (Caste status) once mentioned by the candidates shall not be changed under any Circumstances.

The competent authorities are:-District Magistrate/ Collector or Additional District Magistrate or Sub-divisional Magistrate/Sub-Collectors or Executive Magistrates or Revenue Officers, not below the rank of Tahasildar /Additional Tahasildar of Government of Odisha;

- (x) Required Odia Pass Certificate from the Board of Secondary Education, Odisha indicating Odia as a language subject equivalent to M.E. School Standard or a certificate from the Principal/Headmaster of the recognized school indicating that the candidate has passed Odia upto M.E. standard; if not passed Odia as a subject in the High School certificate examination or equivalent examination;
- (xi) Disability Certificate (indicating percentage of permanent disability) issued by the concerned Medical Board, wherever applicable;
- (xii) If a candidate claims to possess qualification, equivalent to the prescribed qualification, the rule/authority (with number and date) under which it is so treated, must be furnished with the print out/hardcopy of online application form.
- (xiii) Candidates claiming to be Sports persons are required to submit Identity Card issued by the Director of Sports, Odisha, wherever applicable;
- (xiv) Discharge Certificates of Ex-Serviceman issued by the Commanding Officer of the Unit last served wherever applicable. Ex-Servicemen candidates must submit an undertaking that he/she has not appointed against a civil post after retirement from military service.

NOTE-3: Degree Certificate, Certificate showing valid GATE score, Caste Certificate, Odia Test Pass Certificate, Disability certificate of Persons with disabilities, Discharge Certificates of Ex-Serviceman, Identity Card issued by the Director of Sports, Odisha must have been issued by the competent authority within the last date fixed for receipt/submission of application form as indicated above.

10. "GROUNDS OF REJECTION OF APPLICATIONS"

Applications of candidates will be rejected by the Commission on any of the following grounds:-

- (a) In-complete online application form.
- (b) Non-submission of hard copy of online application form at the time of verification of original documents.
- (c) Not signing Declaration (full signature) in the hard copy of online application form.
- (d) Not passing Odia test (M.E. standard)/not furnishing Odia test pass evidence as required under para 7(iii) and para -9(x) of the advertisement.
- (e) Not coming within the age limit as mentioned in Para 3 of Advertisement
- (f) Not having requisite qualification as provided under Para 4 of Advertisement.
- (g) Not furnishing copies of certificates/documents as provided under Para 9 of Advertisement.
- (h) Submission of wrong information/ false information about qualification/ Valid GATE score /Age /category status (SEBC/SC/ST/ Ex-Servicemen /PWD/Woman/Sports Persons etc).
- (i) Suppression of facts / information about eligibility, if any.

(j) Any other ground as per the decision of the Commission.

NB: Application /candidature of a candidate shall be rejected at any stage of recruitment process, when discrepancy is noticed/ detected.

11. HOW TO APPLY:

- (a) Candidates must go through the details of this Advertisement available in the Website of OPSC before filling up online application form.
- (b) Candidates must apply online through the concerned Website of the OPSC http://opsc.gov.in. Applications received through any other mode would not be accepted and summarily rejected.
- (c) Before filling up the online application form, the candidates must go through detailed instructions available at OPSC portal.
- (d) The online application form is automated and system driven & will guide the candidate seamlessly in filling the application. The requisite options shall be enabled and information shall be asked as per data furnished by the candidate. Before filling up the information, ensure that accurate information is fed, for edit option is limited & on confirmation there is no scope for further edit even if wrongful entry has been made while filling up application.
- (e) Candidates are requested to upload the scanned image of latest passport size photograph along with scanned image of his/her full signature and scanned image of Left-hand Thumb Impression (LTI) in the online application form. Uploaded photograph, Specimen (full) signature and LTI must be clearly identifiable / visible, otherwise the application of the candidate is liable to be rejected by the Commission and no representation from the candidate will be entertained.
- (f) Candidates should keep at least four copies of latest passport size photograph which is uploaded to the online application form for future use.
- (g) On successful submission of the online Registration, a unique "Permanent Public Service Account Number (PPSAN)" will be assigned to the applicant. Candidates are required to take a printout of the finally submitted online Registration/Reregistration and finally submitted Online Application forms and put his/her signature under the declaration for submission to OPSC along with copies of requisite certificate & documents as and when asked.
- (h) The candidates are advised to submit the Online Application Form well in advance without waiting for the closing date to avoid last hour rush.
